

JURISDICTION UPDATE

The Tŝilhqot'in Nation continues to advocate for positive changes through Child and Family Jurisdiction.

We are working towards a 5-year Agreement with Canada and BC to expand prevention services and build towards full Jurisdiction. The Nidlin Advisory Team, which is made up of lawyers, negotiators, Tŝilhqot'in knowledge holders, and service delivery experts, continue to attend regular meetings with BC and Canada to negotiate for the best agreement possible.

The team is also attending National conferences to learn from other First Nations who have exercised their Child and Family Jurisdiction.

TL'ETINQOX ?ELHELH GHIDELH AGREEMENT

Congratulations to the Tl'etinqox Government who signed the *?Elhelh Ghidelh: 'Moving Together' Agreement* on September 13, 2024. This Agreement ensures the Ministry of Children and Family Development (MCFD) collaborates with Tl'etinqox when they provide certain services to Tl'etinqox members. This will improve Tl'etinqox's relationship with MCFD until full Jurisdiction is exercised



DENISIQI CHILD PROTECTION DELEGATION

Denisiqi is also supporting the road to jurisdiction by working towards full child protection delegation. With the ability to deliver the full range of child welfare duties, communities will be able to use Denisiqi for all of their prevention and safety needs including child protection.


