The latest information important to T̓silhqot̓'in fish and fishing activities

This is the TNG Fisheries in-season bulletin that is released weekly throughout the salmon season from mid-July to mid-September to provide updates on the state of T̓silhqot̓'in fisheries and work in the field. In-Season Update:

2025 T̓silhqot̓'in Fisheries:

Reminder of the **2025 T̓silhqot̓'in Fisheries Plan** approved by the TNG Council of Chiefs:

- Ja̓ harvest began July 18, with a request to release Ts'eman (sockeye) until August 13. This allows Ts'eman impacted by the T̓silhqox Landslide, including critically endangered Dasiqox and South End Chilko Ts'eman populations, to return to their spawning grounds to support their recovery.
- **GOOD NEWS:** The **earlier version** of the T̓silhqot̓'in Fishing Plan requested voluntary release of Ts'eman until Aug 14; due to good news about Ts'eman returns in-season, this has been updated to **Wednesday, August 13** – a full day earlier.
- Please do not fish in the Che̓qox (Little Chilcotin) **for the full season**, except for the junction area with the Chilko. This protects critically endangered Che̓qox Ja̓ by allowing them to return to their spawning grounds to support their recovery.
- Please see all applicable requested voluntary protection measures in the box below.

We hope you're enjoying the 2025 salmon season, and we're happy to see people on the river successfully catching Ja̓ (Chinook) in the Chilcotin and the Fraser!

2025 Applicable Voluntary Protection Measures:

The T̓silhqot̓'in Council of Chiefs requests voluntary compliance with limited measures to protect early timed Ja̓ (Chinook) and Ts'eman (sockeye) populations at high risk of extinction.

- Please release Ts'eman (sockeye) until **Wednesday, August 13, 2025**.
- Please do not fish for Ja̓ in the Che̓qox (Little Chilcotin) system above the Chilko / Chilcotin junction **for the full fishing season**.



In-Season Information:

TNG Fisheries updates our understanding of salmon returns and environmental conditions throughout the salmon season based on in-season technical information.

From late June to the end of September, we conduct detailed monitoring and analysis of information from the ocean to the spawning grounds, and provide weekly reports through these in-season fisheries bulletins.

Ts'eman (Sockeye) Update:

- Chilko Ts'eman continue to show an encouraging ocean return, and the run remains at a higher number of salmon than was predicted in the pre-season forecast.
- The early part of the Chilko Ts'eman run has moved into the lower Fraser River.
- Over the next week, we will be getting close to estimating the Chilko ocean return run size, which will be our key indicator of how strong the Ts'eman return to the Chilko will be.
- Most of the Fraser River early run sockeye (which return before Chilko Ts'eman) have also exceeded pre-season predictions. However, we still have a conservation concern for highly vulnerable Dasiqox (Taseko) Ts'eman, and are currently planning emergency enhancement on this population in 2025.
- **GOOD NEWS:** The **earlier version** of the T̓silhqot̓in Fishing Plan requested voluntary release of Ts'eman until Aug 14; due to good news about Ts'eman returns in-season, this has been updated to **Wednesday, August 13** – a full day earlier.

Scenes from the Field:

We are officially at our maximum field workload for the year, which will continue until mid-September. Over the past week the TNG fisheries crew has been concentrating on:

- downloading SONAR files from the Taseko SONAR
- maintaining the fish passage SONAR at Hanceville
- counting salmon as they pass through the Hanceville SONAR
- catch monitoring for the T̄silhqot'in Jās fishery
- preparing for Jās and Ts'eman assessment projects based out of the Chilko field camp beginning this week.

Highlights from the Hanceville SONAR:

The TNG Fisheries crew, with technical partner Ecofish, installed the Hanceville SONAR on July 23. It will operate throughout the entire salmon season to monitor salmon past the T̄silhqox landslide impact area.
